

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://picatti.com/>, and Picatti Brothers and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Picatti Brothers include <https://picatti.com/> and Picatti Bros. The Picatti Bros website is a information, ecommerce site. By using the Picatti Bros website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Picatti Bros may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Picatti Bros's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

Sharing Information with Third Parties

Picatti Bros does not sell, rent or lease its customer lists to third parties.

All such third parties are prohibited from using your personal information except to provide these services to Picatti Bros, and they are required to maintain the confidentiality of your information.

Picatti Bros may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Picatti Bros or the site; (b) protect and defend the rights or property of Picatti Bros; and/or (c) act under exigent circumstances to protect the personal safety of users of Picatti Bros, or the public.

Tracking User Behavior

Automatically Collected Information

Security of your Personal Information

- SSL Protocol

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. - Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
